Sub: Rate of Fuel and Power Purchase Price Adjustment Charges (Fuel Surcharge) applicable on the consumption for the month from October 2021 to December 2021 till further communication.

This has reference to our earlier circular dated 31-07-2021 intimating to charge Fuel Surcharge @ Rs.1.90/Unit from all categories of consumers excluding Agriculture consumers from July 2021 and onward till further communication in this regard.

GUVNL has worked out FPPPA of Rs. 2.40/Unit (including base FPPPA Rs. 1.80/Unit) for 2nd Quarter of FY 2021-22 as against FPPPA of Rs. 1.90/unit of 1st Quarter of FY 2021-22. Thus, there is an increase of Rs 0.50/Unit (Rs. 1.90 to Rs. 2.40 Unit) in FPPPA charges for Q2 of FY 2021-22.

As per GERC Tariff order dated 31.3.2021, any levy of fuel surcharge beyond 10 Paise/Unit requires prior approval of Hon'ble GERC.

Since, increase in FPPPA for the 2nd Quarter of FY 2021-22 is 50 Paise / Unit (increase from Rs. 1.90 to Rs. 2.40), which is in excess of 10 Paise per Unit, approval of Hon'ble Commission has been sought for recovery of balance FPPPA of 40 Paise/Unit as per Hon'ble commission order dated 31.03.2021. Meanwhile, it is requested to kindly charge FPPPA at Rs. 2.00/Unit (Rs. 1.90 + 0.10) for the period from 1st October 2021 till further communication, from all categories of consumers excluding Agriculture

consumers since Government of Gujarat is giving subsidy to DISCOMs for Agricultural consumption.
