Sub: Rate of Fuel and Power Purchase Price Adjustment Charges (Fuel Surcharge) applicable on the consumption for the month from January 2022 to March 2022 till further communication.

This has reference our earlier letter dated <u>01-11-2021</u> intimating to chargeFuel Surcharge of Rs. 2.00/Unit from all categories of consumers excluding Agriculture consumers from October 2021 and onwards till further communication in this regard.

GUVNL has worked out FPPPA of Rs. 2.98 per unit (including base FPPPA of Rs. 1.80 per unit) for 3rd Quarter of FY 2021-22. Thus, there is increase of Rs. 0.98 per unit as compared to present FPPPA charges of Rs. 2.00 per unit recovered from consumers.

As per GERC Tariff Order dated 31.03.2021, any levy of fuel surcharge beyond 10 Paise per unit requires prior approval of Hon'ble GERC.

In view of above, it is requested to kindly charge FPPPA at Rs. 2.10/Unit (i.e. Rs. 2.00 per unit + Rs. 0.10 per unit) for the period from January 2022 till further communication, from all categories of consumers excluding Agriculture consumers since Government of Gujarat is giving subsidy to Discoms for Agricultural consumption.

Further, with a view that burden of unprecedented and unforeseen increase in power purchase cost shall not be passed on to the small category of consumers, the balance FPPPA charges of Rs. 0.88/unit of Q3 of FY 2021-22 will not to be recovered from Residential consumers (having consumption upto 200 units per month) and Non Residential consumers having load upto 40 KW and the burden of the same will be borne by GUVNL / DISCOMs. While, the unrecovered FPPPA of Rs. 0.88 per unit of Q3 of FY 2021-22 from other category of consumers shall be recovered as per the manner approved by GERC.

In view of above, it is requested to kindly charge FPPPA at Rs. 2.10/Unit for the period from January 2022 to March 2022and till further communication, from all categories of consumers excluding Agriculture consumers since Government of Gujarat is giving subsidy to Discoms for Agricultural consumption.
