Sub: Rate of Fuel and Power Purchase Price Adjustment Charges (Fuel Surcharge) applicable on the consumption for the month from July 2022 to September 2022 till further communication.

This has reference to our earlier letter dated 19.05.2022 intimating to charge Fuel Surcharge @ Rs.2.50/Unit for the consumption from May 2022 onwards from all categories of consumers excluding Agriculture consumers.

GUVNL has worked out FPPPA of Rs. 3.29/Unit (including base FPPPA Rs. 1.90/Unit) for 1st Quarter of FY 2022-23 as against present FPPPA recovery of Rs. 2.50/Unit. Thus, there is an increase of Rs 0.79/Unit (Rs. 2.50 to Rs. 3.29 Unit) in FPPPA Charges for Q1 of FY 2022-23. Further, there is pending recovery of balance FPPPA charges of previous Quarters of FY 2021-22.

As per Hon'ble GERC Tariff Order dated 31.3.2022, any levy of fuel surcharge beyond 10 Paise/Unit requires prior approval of Hon'ble GERC.

Since, increase in FPPPA for the 1st quarter of FY 2022-23 is 79 Paise / Unit as compared to present FPPPA recovery rate of Rs. 2.50 / unit (increase from Rs. 2.50 to Rs. 3.29), which is in excess of 10 Paise per Unit, approval of Hon'ble Commission has been sought for recovery of balance FPPPA of 69 Paise/Unit of Q1 and unrecovered FPPPA of previous Quarters of FY 2021-22.

Meanwhile, it is requested to kindly charge FPPPA at Rs. 2.60/Unit (Rs. 2.50 + 0.10) for the period from 1st July 2022 till further communication, from all categories of consumers excluding Agriculture consumers since Government of Gujarat is giving subsidy to DISCOMs for Agricultural consumption.
