Sub: Rate of Fuel and Power Purchase Price Adjustment Charges (Fuel Surcharge) applicable on the consumption for the month from April 2022 to June 2022 till further communication.

This has reference to our earlier letter dated 10-03-2022 intimating to charge Fuel surcharge @ Rs. 2.20/Unit for the consumption of February & March 2022 from all categories of consumers excluding Agriculture consumers.

GUVNL has worked out FPPPA of Rs. 2.62/Unit (including base FPPPA Rs. 1.80/Unit) for 4th Quarter of FY 2021-22 as against present FPPPA recovery of Rs. 2.20/Unit. Thus, there is an increase of Rs 0.42/Unit (Rs. 2.20 to Rs. 2.82 Unit) in FPPPA Charges for Q4 of FY 2021-22. Further, there is pending recovery of FPPPA charges of previous Quarters of FY 2021-22.

As per Hon'ble GERC Tariff Order dated 31.3.2021, any levy of fuel surcharge beyond 10 Paise/Unit requires prior approval of Hon'ble GERC.

Since, increase in FPPPA for the 4th quarter of FY 2021-22 is 42 paise / Unit as compared to present FPPPA recovery rate of Rs. 2.20/Unit (increase from Rs. 2.20 to Rs. 2.62), which is in excess of 10 paise per unit, approval of Hon'ble Commission has been sought for recovery of balance FPPPA of 32 Paise/Unit of Q4 and unrecovered FPPPA of previous Quarter of FY 2021-22.

Meanwhile, It is requested to kindly charge FPPPA at Rs. 2.30/Unit (Rs.2.20 + 0.10) for the period from 1st April 2022 till further communication, from all categories of consumers excluding Agriculture consumers since Government of Gujarat is giving subsidy to DISCOMs for Agricultural consumption.
