- 1. That the Petitioner has filed the Petition 2421 of 2024 before Hon'ble Commission for True Up for FY 2023-24 under GERC (Multi Year Tariff) Regulations, 2016 and Determination of Average Revenue Requirement for FY 2025-26 to FY 2029-30, Determination of Tariff for FY 2025-26.' under GERC (Multi Year Tariff) Regulations, 2024 along with other applicable guidelines and directions issued by the GERC.

- 4. The Petitioner respectfully submits that an inadvertent error has been identified under the heading Public Water Works in Clause 4.3.6 of the originally filed petition. The incorrect text reads as follows:

"The connected load added has also been considered to be growing at a subjective rate of 5% going forward."

The corrected text is as follows:

"The connected load added in the category has witnessed a 5 years CAGR of 6.37% between FY 2018-19 and FY 2023-24. The company expects this trend to continue going forward."

  revised text on record and consider it while adjudicating the petition.
- 6. The Petitioner respectfully submits that Table 73: Audited O&M Expenditure for last 10 years in the originally filed petition has been inadvertently pasted incorrectly. The correct version of Table 73 is provided below for the kind consideration of the Hon'ble Commission:

   (A) of the petition mentioned hereinabove, corresponding amendment is required to be carried out in the proposed Tariff schedule.
- 10. The Petitioner respectfully requests the Hon'ble Commission to amend the tariff schedule by excluding Clause 13.9 - 'Time of Use Discount,' which inadvertently applies to the HTP-III consumer category.
- 11. The Petitioner respectfully requests the Hon'ble Commission to consider FY 2025-26 instead of FY 2023-24 in clause no. 5.7.1 due to typographical error.

### 12. Prayer

In view of foregoing deliberations and amending the contents of the original petition, The Petitioner most respectfully pray that this Hon'ble Commission may be pleased to:

- (i) Permit the amendment of the Petition as described above and consider the amendments as part of the original petition
- (ii) Pass such other orders as may be deemed fit and proper in the circumstances of the case


