Respected Sir/ Madam,

Vide GUVNL's letter dated 28/12/2015 (Ref.1), Purchase Policy for Procurement of PSC Poles was circulated to all DISCOMs. Also, vide GUVNL's letters dated 06/10/2016 (Ref.2), 24/08/2017 (Ref.3), 02/02/2018 (Ref.4), 28/03/2018 (Ref.5), 17/01/2019 (Ref.6), and 26/02/2020 (Ref.7), Amendment No.1, Amendment No.2, Amendment No.3, Amendment No.4, Amendment No.5 and Amendment No.6 respectively were issued and conveyed to all DISCOMs.

Now, in view of submission of CE (T&O), MGVL vide letter no. 813 dated 13.11.2020, the Competent Authority of GUVNL has approved the modifications in Purchase Policy-2016 for Procurement of PSC Poles as per following details.

Existing clause No. 3.6.3 and 3.6.4 shall be substituted by following clauses.

3.6.3 The Micro and Small Scale Industrial (manufacturing) Units registered under Small Scale Industries of Gujarat State and holding subsequent registration with CSPO / NSIC / DGS&D, Registration Certificates for the item under Tender will be eligible for exemption from payment of EMD on submission of attested copies of their SSI (SSI/ MSME Part-II/ Udyog Aadhaar Memorandum/ Udyam Registration Certificate) & CSPO / NSIC / DGS&D Registration Certificates in EMD Cover. This benefit of exemption will not be admissible if they take part

in the tender indirectly either through their dealers, agents, distributors or other intermediators.

- 3.6.4** The Certificates should indicate the manufacture of items offered. In case of Udyog Aadhaar Memorandum / Udyam Registration Certificate, it should indicate the manufacture of related group of item.


Note for clause no. 3.6.3 & 3.6.4:

In view of Ministry of Micro, Small and Medium Enterprises, Govt. Of India, New Delhi Notification S.O. 2119 (E) dated 26th Jun, 2020 and subsequent clarifications issued vide O.M. No. 2/1(5)/2019-P&G/Policy (pt. IV) dated 6th August, 2020, only "UDYAM REGISTRATION CERTIFICATE" out of SSI / MSME Part-II / Udyog Aadhaar Memorandum / Udyam Registration Certificate shall remain valid from 1st April 2021.

You are, therefore, requested to instruct the concerned officials to take necessary action to follow above provision for procurement of PSC Poles scrupulously, after observing all the formalities, please.
