Respected Sir,

Vide GUVNL's letter dated 28/12/2015 (Ref.1), Purchase Policy for Procurement of PSC Poles was circulated to all DISCOMs. Also, vide GUVNL's letters dated 06/10/2016 (Ref.2), 24/08/2017 (Ref.3), 02/02/2018 (Ref.4) and 28/03/2018 (Ref.5), Amendment No.1, Amendment No.2, Amendment No.3 and Amendment No.4 respectively were issued and conveyed to all DISCOMs.

Subsequently, for smooth implementation of GST, the Competent Authority of GUVNL has approved the modifications in Purchase Policy for Procurement of PSC Poles, as per following details:

The existing Clause No. 3.12 shall be substituted by the following Clause:

- 3.12 Penalty shall be @ 0.5% per Week or part thereof plus GST and Cess as applicable on delayed portion subject to maximum 10% plus GST and Cess as applicable of the Order Value (End Cost including GST and Cess as applicable). For calculating the delayed portion, date of actual tested poles at site/Pole factory shall be considered.

You are, therefore, requested to instruct the concerned officials to take necessary action to follow above changes for procurement of PSC Poles scrupulously, after observing all the formalities.
