c. <u>The modalities of utilization of funds and implementation schedules for the projects or programs</u>

Modalities of utilization of funds:-

1. The Funds will be disbursed upfront or in phased manner/tranchewise to the Implementing Agency(ies) depending on the nature of the project. On the basis of the terms agreed upon and/or as mentioned in the respective resolution/agreement/MOU, as the case may be, or on the basis of the expenses incurred and upon submission of the relevant supporting documents of the expenses e.g. bills, receipts, invoices, bank statements, etc., the respective amount will be disbursed accordingly.

• Project implementation schedule:-

- 1. All the CSR projects will be implemented as per the approved scheduled timeline in the respective resolution/agreement/MOU.
- 2. Duration of CSR projects/initiatives will be of maximum period not exceeding three years which will be annually reviewed.

d. Monitoring and reporting mechanism for the projects or programs;

- 1. The monitoring mechanism of each project will differ on the basis of the nature of the project. All the projects will be monitored and evaluated as per the objectives & deliverables set for respective projects as per the approvals.
