Respected sir,

Under the SURYA-Gujarat scheme, the charges for Generation Meter, Meter Box and Meter Testing charge were determined by averaging the purchased cost of meters from each DISCOM, ensuring a uniform rate for cost recovery. Charges for applications up to 100 KW (LT Connection) for GUVNL DISCOMs are as under;

It has been learnt that with the transition to processing rooftop solar applications through the National Portal, DISCOMs are recovering charges, which vary among all DISCOMs.


Recognizing the government's commitment to promoting rooftop solar installations in the residential sector, it is imperative to encourage public participation.

In view of this, the matter was put up before the Competent Authority of GUVNL and it has been decided that the charges for Net / Generation Meter, Meter Box, and Meter Testing for rooftop solar applications in residential sector on national portal, align with the rates established under the SURYA-Gujarat scheme so that uniformity should be maintained in GUVNL DISCOMs.

It is also inform that the new template naming "PMSY RTS" is under development in e-urja module with considering above rates to maintain the separate record for applications registered on National portal. Upon development, it will be implemented.
