Sub.: Nomination of Nodal DISCOM/Agency for Vendor Registration in PM Surya Ghar Yojana-reg.

Respected Madam,

Earlier, MNRE had issued various guidelines for Vendor registration on National portal under simplification process since 2022.

Accordingly, the procedure for vendor registration was adopted in line with prevailing practice as per policy for Procurement of materials and guidelines was issued vide GUVNL's letter dated 01-08-2023, wherein vendors are required to register their applications with the concerned DISCOM in whose jurisdiction the vendor's corporate office is situated. Said DISCOMs are collecting the PBG from the vendors on behalf of all DISCOMs including Torrent Power. These vendors' registration is applicable for entire Gujarat State. Also, vendors whose corporate offices are located outside Gujarat are required to register their applications with the concerned GUVNL DISCOMs in line with the vendor registration process outlined in the purchase policy for procurement of materials. Currently, this process is conducted offline.

Now, MRNE, vide D.O Letter dated 30-10-2024 has requested to nominate Nodal DISCOM/Agency for the registration of the vendors at State/UT level as the Ministry is in process of making the State/UT level vendor registration online. The online applications are proposed to be forwarded to the Nodal DISCOM/Agency in their login, wherein they can accept/reject the applications.

It is learned that PGVCL has started implementation of acceptance of Bank guarantee through Electronic Bank Guarantee (e-BG).


In view of above, as approved by the Competent Authority of GUVNL, PGVCL is nominated as a nodal DISCOM for on-line Vendor registration on PM Surya Ghar portal on behalf of all DISCOMs of the state.

Other procedures to be followed as per MNRE Guidelines issued from time to time regarding state level vendor registration.

It is requested to instruct the concerned officers to take appropriate actions, in this regard, after observing all the formalities, please.
